For each additional

Adult: Add additional \$1,090/month/Adult or \$13,075/year/adult

Child in Childcare: Add additional \$1,270/month/child or \$15,224/year/child in childcare

School-age child: Add additional \$660/month/child or \$7,910/year/school-age child
