

Hunterdon Hygiene Connection

With the support of our generous donors, Hunterdon Hygiene Connection helps to relieve the financial burden, which can average \$1200 per year, of personal hygiene products that are essential for health and wellness. Diapers, period products and adult incontinence products are distributed to individuals and families in need through a collaborative network of 14 community partner organizations. Originally established as the Hunterdon Diaper Bank, this initiative was rebranded to reflect the expansion of available products.

Tools 4 School – Summer, 2022

Tools 4 School is an educational initiative that support students and families in need prepare for the upcoming school year. Working with Hunterdon County schools, the program aims to ensure that students have the necessary tools, supplies, and resources to start the school year successfully. The program involves collecting and distributing school supplies such as backpacks, notebooks, pens, pencils, calculators, and other essential items donated by individuals, businesses, and community organizations.

VITA – Tax Year 2021

The Volunteer Income Tax Assistance (VITA) program, funded in part by an Internal Revenue Service (IRS) grant, offers free tax preparation services to individuals and families with low to moderate incomes. The program is run by certified volunteers who receive training from the IRS to assist taxpayers in accurately preparing their tax returns.

VITA volunteers provide guidance on tax credits and deductions to help taxpayers maximize their refunds. They can also help individuals determine if they are eligible for certain tax benefits, such as the Earned Income Tax Credit (EITC) and the Child Tax Credit (CTC). The VITA program aims to ensure that eligible taxpayers receive all the credits and deductions they are entitled to, thereby maximizing their financial resources.

Volunteers are at the heart of our community impact, and each year we honor one individual who has


